 - 2) No building permit will be issued until the cultural heritage process regarding Studios B and C has been completed.
 - 3) The entitlement will be reduced to seven years.
 - 4) The project will continue to work with the residents of the Selma/LaBaig/Harold Way Historic Area to resolve traffic/parking concerns.
 - (e) 5609 Sunset Blvd. 7/11 store (across from Home Depot) Request for approval of beer and wine sales. AA 2010-317-318-EAF, PLUM Committee action: Unanimous recommendation of Approval if the following additional (to LAPD) conditions are required:
 - 1) No single can or single bottle sales and no malt liquor sales.

- 3) Armed Security Guard: Monday-Friday: 4PM-1AM; Saturday and Sunday: Noon-1 AM
