Councilmember Eric Garcetti 200 North Spring Street, Room 470 Los Angeles, CA 90012 *On June 11, 2012 by official action of the full board of the Hollywood Studio District Neighborhood Council, we voted to rescind our letter dated November 14, 2011, due to discrepancies in our boundary description of previous letter dated June 7, 2011. The letter below declares our official position along with correct boundries.

Re: Request for a Moratorium to be placed on current and future front yard violations

Dear Council President Garcetti and GM Ovrom:

This letter is sent to you on behalf of the Hollywood Studio District Neighborhood Council (HSDNC).

The HSDNC voted on June 13, 2011 to issue this letter requesting that the Department of Building and Safety in conjunction with the office of Council President Garcetti issue a moratorium for the issuance of previous and future citations, fines and liens for over height fences and paved front yards until December 31, 2016 within the boundaries of the HSDNC, with the exception of the area falling between Melrose Avenue, Santa Monica Boulevard, Western Avenue, and the 101 Freeway, comprising the Melrose Hill Neighborhood.

The HSDNC also voted to request a letter from the City Council Office to recommend a permanent Over Height Fence district be created within the HSDNC boundaries, with the exception of the area falling between Melrose Avenue, Santa Monica Boulevard, Western Avenue, and the 101 Freeway, comprising the Melrose Hill Neighborhood. Further the HSDNC requests that the Council District approve a waiver of all filing fees and cost related to the application and creation of the over height fence district.

The HSDNC requests that the City Council District 13 to pay for the cost of a letter regarding the proposed issuance of an Over Height Fence District to all residences and property owners within the HSDNC boundaries and/or alternatively request Council President Garcetti's office to include the letter within his next newsletter; as a way of assisting the HSDNC in involving the community and broadening community outreach.
