- 6. **Report by City Officials** CD 13 Angela Motta/Ryan Carpio No one present for report.
- 7. **Presentation by City** of L.A. DOT re "Watch the Road" program

Bruce Gillman gave an overview of the program; only 15 NC's requested the 100 free personalized signs and HSDNC was one, so we are above average. When they arrive, signs should be placed on private property within our NC area ASAP. Additional signs are available for a nominal cost at: www.ladot.lacity.org

- Question about 1 hr parking on Hollywood Blvd. more input Suggested contact Jeannie Shen in Tom Labonge's office who is the area representative; have a counter open three days a week for information and service requests
- LAPD Commission not DOT runs valet parking; DOT does grant temporary no parking signs for special
  events
- Speed humps are paid for by gas tax; has not been paid in two years by State; 75% of residents on affected streets would need to sign petition for speed humps, which cost about \$1200 \$1500. DOT will partner with third party vendors
- Frank: Would like to take overseeing these fines into parking/transportation committee. Hope Senator Price's office will work with us and the DOT to address these concerns. DOT priority list?
- 8. **Presentation by Armen Makasjian** re Route 66 Car Show gave an overview of project:

Education/Building Community/Clean Up; Engaging the Community; Economic Alliance; Working with non-profit partner. \*Route 66 Car Show – in planning stage; working to collect sponsors and publicize. Hope to give publicity to the EHNC area.

- b. **Discussion and possible action re approval of up to \$1,000** to sponsor stage for Make Music LA at Hollywood and Vine Metro Plaza on June 21. Request is withdrawn because couldn't work out details with Metro
- **c. Discussion and possible action re request from stakeholder Albert Tsao** to fund up to \$500 for food, beverages, and supplies for neighborhood clean up at Lemon Grove Park on July 28.
  - Eric Kinzh spoke on the community clean up day, requesting assistance for food/water/barbeque for all volunteers; organized by group of churches and community members in conjunction with City (Albert lives in EHNC area but lives adjacent and has kids in pre-school in HSDNC.) Organization is Servethecity.org. Asked for HSDNC volunteers

- 11. **PLUM** Committee has not met for two months, so there is no update.
  - a. Discussion re Old Spaghetti Factory lot sale and tax assessment issue Bill Zide gave an overview of issues: Broken agreement with Hollywood Heritage; property tax issue; downgrades value
    - Bill will draft letter for presentation to PLUM Committee. Juri recommends collecting information/documentation from City to assure we have done our homework before issuing a letter

- 12. Bylaws / Elections Committee
  - a. Discussion and possible action re proposed revision to Article X, Section C, Officers:

Discussion and possible action re proposed revision to Article X, Section C.,

### Officers:

1. After the election and appointment of Board Members, the Board by simple majority will vote to elect from among its Members the following officers, at a public meeting: Chairperson, Vice Chairperson and Treasurer. The Officers will serve for a term of two (2) years or until the next regularly scheduled election has been certified and Board Members seated and will serve at the will of the Board.

**Proposed new provisions**: "To qualify to serve as such, the Chairperson must have served as a Board member for at least one year prior to being elected by the Board. All other Officers may serve without having previously served on the Board."

**Public Comment**: Ziggy Kruse – shocked that this verbiage is still on the Agenda as there has not been a Bylaws committee meeting to discuss this. She said she had volunteered to serve on the Committee and has never been contacted. If committee has met since March without committee members then who was attending these meetings? Who is making these decisions? Could not find the Agendas or Minutes from any Bylaws meetings.

**Response**: Committee Chair **Ken Ostrow** said the committee had met on August 3, 2011, September 28, 2011, and January 17, 2012. No meetings since this time.

**Steven Whiddon**: This Board does not conceal information or hold secret meetings; 12a is on the agenda because it has not been voted on by Board since last committee meeting. This idea was vetted by the committee and recommended.

Suggestion is to send 12a back to committee to revise language to include "if none of the new Board has served for one year, than this requirement is null and void.

  - Steven thanked Jenny for her years of service and hundreds of hours in assisting w/development of new website and training.
  - Alex thanked Jenny for her unwavering support within the community, but especially at the Fountain Community garden
  - Genelle thanked Jenny for much appreciated technical support.
- c. Discussion and possible action re applicant Christina Derenthal as Business Tenant Governor to fill seat vacant by Jenny Weatherholtz
  - Jenny said she believes Christina will continue her dedicated community support and will be an asset to HSDNC

**Public Comment**: Ziggy Kruse: When was this hear by committee:

Committee Chair: Ken Ostrow: There is no Bylaw requirement for candidates to be vetted in committee.

**Kruse**: recommends that this be listed in a different portion of the Agenda so it is not misleading; feels this is a defective part of Agenda

Toussounian: disagrees with Ziggy

**Whiddon**: We are always open to helpful suggestions; changed the Agenda to group items based upon the area that they relate to. This falls under the prevue of the Elections area.

**Kruse**: suggests "update" be removed so that the listing is presumed to be a summary of action taken

**Motion** by Whiddon, seconded by Rodriguez, that Christina Derenthal fill the vacancy **Vote**: Unanimous in favor

- d. **Discussion and possible action** re Grievance filed 1/15/12 Suspected Brown Act Violation re second Moratorium letter
  - 1. Discussion and possible action re challenge to the agenda dates November 14, 2011, item numbered 10.4 and the subsequent board action taken creating discrepancies in our boundary description of previous letter dated June 7, 2011.
  - 2. Discussion and possible action to set aside action taken approving the letter dated 11/14/11.
  - Steven read supporting documents and letters. In consulting with City Attorney it was confirmed that a Brown Action violation did exist in the second letter not being properly agendized and a different area of exemption was included in the second letter.
  - Two letters in question dated 6/27/11 and 11/1411; City Attorney recommends rescind second letter dated 11/14/11
  - Would need to submit a new letter one is included in agenda with preface stating as such.

**Public Comment**: **Doug Haines**: would like to request that language of citation law be included in the letter.

**Ripnsky**: Does the HSDNC Board not have the right to correct a clerical error during a meeting? Yes. Board members have attended community meetings, meeting with the LA City and more.

- e. Introduction of Christine Jerian, Independent Election Administrator/Central Region #5
  - Christine reminded the group of her background working for DONE, etc. She said elections for Region 5 are scheduled for September 16; Election stipulation worksheet to be approved
  - Also need an outline plan for Outreach
  - Election day logistics needed by July 1; Aiming to bring together all Region 5 NC's to pool outreach opportunities.
  - July 18 Aug 17: want to have a pool of candidates; Aug 18<sup>th</sup> candidate filing forms due.
  - Include vote by mail? August 18<sup>th</sup> would be deadline
  - If decision cannot be reached by July 1<sup>st</sup>, default to DONE 4-hour election & no vote by mail.
  - Time and Location: Sunday 9/16 (first day of Rosh Hashanah) potentially move to 9/15
  - \$500 start up fee for vote by mail; plus fee per vote & postage
  - Decisions Tonight Assistance League or Santa Monica Blvd. Community Charter School
