WHEREAS, rapid turnover in board membership impedes the ability of a neighborhood council to act on behalf of its stakeholder; therefore be it

RESOLVED, the Hollywood Studio District Neighborhood Council recommends that the Department of Neighborhood Empowerment extend the term of the Board elected in 2018 from two to three years.
