10. NEIGHBORHOOD PURPOSE GRANTS

a. MOTION: To approve a Neighborhood Purpose Grant up to \$5,000 for the Sidewalk Project. **(PUBLIC SAFETY COMMITTEE)**

Description:

"Our intent to use this grant money would be for operational costs to expand our work and services in the Hollywood Area of Los Angeles, Ca. We already serve Hollywood with our Syringe Exchange & Harm Reduction services but would like to expand our reach. We are also pushing back against the opioid epidemic by supplying Narcan to unhoused folks in Hollywood."

 MOTION: To approve a Neighborhood Purpose Grant up to \$5,000 for Lending Relief. (PUBLIC SAFETY COMMITTEE)

Description:

"The purpose and intent of this grant is to continue our commitment to the most vulnerable of Los Angeles. Lending Relief is a 501c3 non-profit organization that exists to bring relief to homeless and low-income individuals in Los Angeles. Our mission is to Create Lifelong Change that Breaks the Cycle of Poverty. We achieve this through our 3 outreach programs: Hygiene (Relief) Kits, Diaper Need, and Period Poverty. We provide basic immediate needs to programs and people to build stronger communities."

c. MOTION: To approve a Neighborhood Purpose Grant up to \$5,000 for Benekit. (PUBLIC SAFETY COMMITTEE)

Description:

"We are seeking \$5,000.00 in order to provide 400 unhoused citizens of Hollywood with an emergency essentials kit containing warm clothing, toiletries, feminine products, food, water, and some inspiration."

Background:

This CIS has been drafted to support the approval of motion for the RFQ to hire a consultant to write the Municipal Bank of Los Angeles (MBLA) business plan. The motion is scheduled for a hearing in the Economic Development and Jobs Committee on May 11, 2021. **Council File: 19-1235.**

A public bank will allow LA to leverage its existing resources and new Federal spending in a way only available through a chartered bank. A public bank will be able to quickly deploy loans and bond purchases. Loans will generate local revenue and profits and keep loan repayments within localities, creating an intergenerational transfer of wealth. (sourced: Public Bank Los Angeles, "PBLA")
