Hollywood Studio District Meeting Minutes

September 11, 2023, 6pm, Lemon Grove Recreation Center

I. Call to Order and Board Roll Call

The meeting was called to order at 6:03pm.

Present: 6 Rafael Borja, Alison Brotherton, Michael Krupa (Arrived at 6:15pm), Evan Holloway, Kerith Kelly, and Leon Randolph

Absent: 3 Eileen Rogers, Robert Rohrer, and Cathy Hood

II. Government Reports

Declan Floyd from State Senator Anthony Portanino's office shared some information on behalf of the State Senator. He discussed the following bills:

- SB41, which would allow Neighborhood Councils to have more flexible meetings including virtual or hybrid options. It has passed in the legislature and is waiting on the governor's signature. Then, the bill will go to the City Council and Neighborhood Councils will be able to take a 2/3rds vote.
- Declan said SB799 was currently going through the process and would allow workers on strike to claim unemployment benefits after being on strike for 2 weeks.
- A board member asked about SB553. Declan shared some information about this bill but was not very clear on it and offered his contact information to board members to follow up about it. The basic understanding of the bill was that employees should not interfere with people stealing. It was currently in the assembly and would come back to the senate by Thursday (last day of the session).

Senior Lead Officer Jesse introduced himself to the board and shared some updates regarding crime and other happenings in the district.

- SLO Jesse said that most crime, especially violent, is down only 6 homicides in Hollywood in the last year. There were no homicides in the district area in the past year. Robbery was also down 14%. Aggravated assault was down 14.5%. However, property crimes had risen including burglary from vehicles and homes as well as retail shop lifting thefts.
- Kerith Kelly asked about encampments in the area. There was discussion about limitation of what officers could do regarding cleaning encampments. He also mentioned advocacy for an Inside Safe program in the area.
- SLO Jesse also shared about a shooting incident at Bernstein High School.

The board moved to section 8a.

VIII. New Business

A. Dept of Transportation Hollywood Blvd Safety and Mobility project presentation

- Lameese Chang, LADOT planner, presented on upcoming traffic safety updates to Hollywood Blvd. between Gower and Lyman and provided the board with informational material. Implementation was expected to start next year.
- SLO Jesse asked about Santa Monica and Gower and issues with the traffic there when
 events were taking place at the Cemetery. Board members expressed concern
 regarding traffic on Santa Monica in general.
 - Ms. Chang explained that these updates were happening based on studies indicating Hollywood Blvd. had many accidents occurring and research would continue and she would bring this up to her department.
- Allison Brotherton asked about the consideration of parking in this project.
 - Ms. Chang said that there would be some parking loss but they were not proposing parking removal overall. LADOT would be sure to notify businesses impacted by this

Raul Preciado shared an update from DONE.

- Mr. Preciado discussed materials he had provided to board members including a work plan for Neighborhood Councils in exhaustive efforts. He suggested board members take a look at this document and send him information via email. At the next meeting, Raul said he would bring an updated work plan to the next board meeting.
- Mr. Preciado also discussed board members ensuring they take the necessary trainings in Cornerstone. He also talked about Planning 101, which is a requirement if boards have a PLUM committee but because this NC was in exhaustive efforts this was not yet required but suggested.
- Mr. Preciado said signers and bank card holders need to take Financial Officer trainings which are offered live twice a month.

Leon Randolph motioned to appoint Jake Hoffman to a Business District board seat. Rafael Borgas seconded the motion.

VIII. New Business

B. Status of hsdnc.org and domain tools

 Michal Krupa shared that the gmail was not set up because no payment was made on the account, once this was sorted out, he would be able to set everyone up with emails.

- Mr. Krupa asked about users on the wordpress: Wendy Moore and Heidi Vanmoore. Allison Brotherton said she did not recognize the names, Michal said he would remove them. He also suggested that anyone who wanted to post on the wordpress reach out to him so he could set up their account.
- Michal said he would disable the committee section on the website because the NC was in exhaustive efforts. He also asked board members to review the Resources and affiliations section to see if there was anything they should add or remove from the section.

C. Request that the NC printer located at 5500 Hollywood Blvd be picked up by Konika-Minolta and no longer rented by the board.

- There was discussion about the board having access to a printer in storage. Allison
 Brotherton suggested the item be tabled until this was sorted out to see if this would be
 necessary or not.
